# **How Do You Apply?**

To request an application <a href="https://housingconnect.nyc.gov/PublicWeb/">by mail</a>, send a self-addressed envelope to: Attorney Street Apartments c/o Wavecrest Consulting LLC, 87-14 116th Street, Richmond Hill, NY 11418. Only send one application per development. Do not submit duplicate applications. Do not apply online and also send in a paper application. Applicants who submit more than one application may be disqualified.

Applications must be postmarked or submitted online no later than August 28, 2024. Late applications will not be considered.

# What Happens After You Submit an Application?

After the deadline, applications are selected for review through a lottery process. If yours is selected and you appear to qualify, you will be invited to submit documents to continue the process of determining your eligibility. Applicants are usually contacted from 2 to 10 months after the application
